EXPLORING LIVERPOOL'S MULTI-AGENCY APPROACH TO A LARGE-SCALE EVENT

INTRODUCTION

In May 2023, Liverpool hosted the Eurovision Song Contest on behalf of Ukraine, involving 37 competing nations.

With over 12,000 accredited staff involved in the planning and delivery of Eurovision, it is the largest and most complex multi-agency (MA) event that Liverpool has ever hosted.

AIM

In the preparation and delivery of a largescale live event:

- To identify the key themes associated with a MA approach (i.e. relationship building, consistency, longevity, trust).
- To investigate the ways in which MA information sharing takes place (informing a UKRI Future Leaders Fellowship on international law enforcement information exchange).

METHOD

Four methods of data collection are adopted:

i. Field observations: MA meetings, MA tabletop exercise, and live events (opening ceremony, semi-finals, final).

- iii. Policy documents
- iv. Interviews

Quantitative (descriptive) and qualitative (content, thematic) analyses will be conducted.

ONLINE SURVEY: SAMPLE

23 participants completed the survey.

INITIAL FINDINGS

FIELD OBSERVATIONS

In the many examples of MA working and information sharing observed, trust, communication and relationships were critical - and were facilitated by a dedicated time and space (i.e. MA meetings) and colocation (i.e. the JCC).

ONLINE SURVEY

Participants identified the key agencies they worked with:

- 1. Merseyside Police (74%)
- 2. BBC (61%)
- 3. Culture Liverpool (44%)
- 4. ACC Liverpool (39%)
- 5. Liverpool City Council (30%)
- -61% worked 'very well' with partners.
- -100% attended MA meetings.
- -MA meetings were 'very useful' for:
 - sharing information (74%).
 - developing & strengthening relationships (70%).
- -86% said relationships improved.
- -100% shared information with partners
 - 83% did not have security concerns.
 - 57% shared information urgently.
- -96% thought the MA approach to Eurovision was a success.

CONCLUSION

Once data collection and analysis is complete, key learning will be shared, focusing on what works well and what could be improved when multiple agencies work together to plan and deliver a large-scale live event.
