## RECORDER AND ABSENCE OF JURISDICTION.

There was an unusual feature about a case that came before the Recorder at Oldham Quarter Sessions to-day. It was one in which Janie Eastham (20), who had been charged with stealing a Shepherd-street Mission box, containing 30s., from inside the Empire Hotel, Tithebarn-street, Preston, had been sent by the

taining 30s., from inside the Empire Hotel, Tithebarn-street, Preston, had been sent by the magistrates.

The Recorder said it was a case that had been sent to him by the Preston Justices, who had power to do so under certain circumstances. Before doing anything in the matter he would like Mr. Lloyd, barrister, of Liverpool, who had been briefed in the case, to give his view on section 14 of the Criminal Justices Act, 1925. The section said that the Justices before whom any person was charged with any indictable offence could be committed for trial to the Sessions of some other town, with a view of saving expense and delay, so long as the Sessions at the place where the offence was committed were not to be held within a month of that date. He understood that Preston Sessions were being held next Tuesday. That being so they would be held within a month of the date when the woman was charged at Preston. If he had any discretion in the matter it would be to send her back to Preston.

Mr. Lloyd said he had looked up this section, and was satisfied in his mind that that court had no jurisdiction in the matter. The question then arose what had they to do in the matter. He would suggest they had power to send her back to Preston to be deallt with at the sessions there.

The Recorder: If I have no jurisdiction

The Recorder: If I have no jurisdiction why should not the people who brought her here take her back again. She was not sent here for trial, she was only sent to me for judgment.

I will direct that this matter is dealt with
by the Preston Quarter Sessions. The

SHEPHERD-STREET MISSION PBOX. GIRL'S ALLEGED THEFT FROM A PRESTON HOTEL. Oct ? 1934 7. Oct 1

Janie Eastham (20), of Preston, was committed for trial at Oldham Quarter Sessions by the Preston magistrates to-day, when she pleaded guilty to stealing a Shepherd-street Mission box, containing 50s., from inside the Empre Hotel, Tithebarn-street.

Mr. A. Blackhurst, who prosecuted, said that fast Thursday morning Eastham went into the hotel and ordered a drink. The barman, Wm. D. Redfern, served her and then went upstairs. When he came slown she had gone, leaving her deink practically untouched. Later it was found that a money box belonging to the Shepherd-street Mission was missing. The same afternoon Eastham went into the Old Dog Inn in Church-street and ordered a drink. When it was served she asked the licensee, Mr. Harry Vickers, to wait a minute whilst she went outside. Mr. Vickers assented, and when she returned he saw that a bulky object which he had noticed under her coat was missing. Then she paid for the drink in coppers, and Mr. Vickers observed that she seemed to have a pocketful of small coins. "Have you been playing nap?" he asked her, and she replied, "No: I got these playing dominoes." Then she went out, and later Mr. Vickers was told that a burst mission box had been found in the backyard, so he gave information to the police. Eastham was arrested on Monday, and when charged she rep ed, "That's not right."

Eastham took no interest in the court proceedings but stood in the dock, her head low, hiding her face from the public. When asked if she wanted to say anything she shook her head.
